3. Secretary Report was shared all information listed below.

- July 16th approval was granted to order 6 cases of 12" softballs for the upcoming season for the price of \$63.99 for a box of 12.
- July 21st approval was granted for a 14U "Right off the Bat Round Robin" held at North Middleton on September 7th consisting of 6 teams. All proceeds will go towards the 14U account.
- July 30th approval was granted for a 10U Tournament to be held on October 5th at North Middleton.

- August 22nd approval was granted for a donation to the Phoenix Warrior Head Coach who passed away. 14U assisted with a donation of \$120. The organization donated \$130. A card assisted the donation from the PA Impulse family.
 - August 23rd approval was granted for personalized cooling towels and towels for the girls belt loops.
 - August 25th the following fundraisers were approved for 12U:

 - September 3rd approval was granted for a New Enterprise driver to deliver dirt to North Middleton. New Enterprise will deliver for a 24 ton total of material, plus delivery which will total \$1,510.48.
 - September 4th approval was granted for a 14U fundraiser for donations to breast cancer and 25% of the donations will go to the 14U team.
 - September 6th approval was granted to purchase a 8 x 10 shed at \$300 for North Middleton fields with a towing fee of \$200.
