- 1. **Public Comment**: No Public Comment
- 2. Treasurer's Report was shared all information listed below.

- 3. Secretary Report was shared all information listed below.
 - December 31, 2024, approval was granted for a cooler for Boozapalooza.
 - On January 9, 2025, approval was granted to purchase a \$300 Visa card and a fruit basket/flower arrangement for the Lutz family.
- 4. Roster count totals listed:

- 5. **Allentown Skills Clinic** It was communicated that the clinic will be attended next year, noting that the girls learned a lot while attending the clinic as well as enjoyed the time they were at the clinic. There is an interest in holding a team camp at the Allentown Skills Clinic.
- 6. Tournaments for Each Team
